

## INTRODUCTION

---

**H**AVE YOU HEARD ABOUT THIS, nurses and medical staff and doctors? There is a category of products which is given out like a present to many, many people in the United States every year and it generates **one adverse event report for every 39 products bought and used**, according to a **large 2010 study of 715,000 Americans by Health and Human Services (HHS)**. [1]

This category of products also is known to be responsible for about 19.5% of ADEs (adverse drug events) in the emergency room for children under age five. [1] However, adverse events due to this category of products are estimated by the US government to be under-reported by a factor of 100. [1] 491,000 children in India are presumed to have gotten acute flaccid paralysis as a result of using a product in this category between 2000–17. [1a] That same product even inspired this gem in the June 1<sup>st</sup> 1984 edition of *Federal Register*, the daily journal of the US government (my emphasis added in bold):

However, although the continued availability of the [redacted] [product] may not be in immediate jeopardy, **any possible doubts, whether or not well founded, about the safety of the [redacted] [product] cannot be allowed to exist** in view of the need to assure that the [redacted] [product] will continue to be used to the maximum extent consistent with the nation's public health objectives. [1b]

There is an entire movement of people who are warning about the great dangers of this category of products and they have vast bodies of work to support their contentions. One book cites 438 studies which are critical of this category of products [2], and its author, unsurprisingly, has been slandered as some kind of a UFOlogist. This is typical. One website database [3] includes more than ten thousand relevant links “to abstracts and full text articles from peer-reviewed literature that is difficult to find elsewhere but easy to find” there. RFK, Jr.'s platform, [Children's Health Defense](#), uncovers many excellent studies. The Weston A. Price Foundation has covered the topic generously. The media says that only misinformation posts on Facebook claim this category of products is unsafe, instead of admitting that there are very substantial bodies of work on this topic produced by reputable experts. The US Supreme Court, in the year 2011, repeatedly called this category of product “unavoidably unsafe” and claimed this was a good reason to further remove civil liability from the manufacturers in the realm of design-defect claims, claims which allege that the manufacturer could have made a safer product. Even though HHS is its parent agency and clearly found an adverse event report rate of 1 report for every 39 products administered, the CDC has, along with other US government agencies, consistently stated that serious injuries from these products occur at a rate of approximately 1 in a million (which is obviously untrue).

Meanwhile, governments have been “marching in lockstep” to mandate these products. As it turns out, the products I'm talking about are actually pharmaceutical products, and, yes—you guessed it—they are vaccinations, as in: “**...any possible doubts, whether or not well founded, about the safety of the vaccine cannot be allowed to exist...**” [1b]

My chapter on vaccinations, 'THE GOVERNOR,' is required reading for everyone who sees this report (so is the whole book but the target audience of this Safety Alert should start there, because of the late hour). The book is free in PDF format at my website, [www.InsultingConsulting.net](http://www.InsultingConsulting.net), and I

have vowed not to make any royalties on the book for good reason: I don't want anyone to be able to say convincingly that I only wrote the book to make money selling books. There should be no obstacles standing in the way of people adopting the information. However, all of what has been mentioned above was the true even before the coronavirus lockdowns; it is likely that the newest products in this category are more dangerous than the ones that are currently “licensed” and on the market in the USA.

Comprehensive coverage of the topics at hand should be saved for other reports, i.e. my upcoming coronavirus report (G-d willing). My interest in writing this short Safety Alert is in preventing the loss of life and quality of life of people who are generally altruistic but are expected to be tasked with administration of billions of doses of an exceedingly dangerous pharmaceutical to the public—both to themselves and to others.

It is required and not optional for readers of this Safety Alert booklet to read the vaccinations chapter of my book. That chapter is called 'THE GOVERNOR.' If there are any doctors or nurses out there who might say they are sure they would not have any misgivings about taking (or administering) a coronavirus vaccine, they should read that chapter! It should cause any person to begin the process of taking a second look at vaccines, a look beyond the propaganda with which they were trained in elementary, middle and high schools; college; medical school; nursing school or other job training.

In that chapter the readers should learn, among many other things, about the CBS *60 Minutes* segment from 1979 which I tried to buy from CBS but couldn't. The only reasonable conclusion: CBS was effectively censoring itself; that 1979 segment was an example of good investigative journalism and the company has since then turned completely into a government-approved news outlet. Through the journalistic work done in that good segment it was thoroughly exposed that the manufacturer knew the shot would cause neurological damage and that various well-known public figures had been cited as recipients of the shot (Mary Tyler Moore was one of these but she told *60 Minutes* on camera that she did not ever take that shot or agree to have her name used for that purpose). After all of this, the very level-headed and articulate husband of Mrs. Judy Roberts (she was a recipient of the 1976 Swine Flu vaccine and thereby became a paralyzed GBS victim), Mr. Gene Roberts, said to *60 Minutes* crew (my emphasis added in bold):

Maybe that's why *60 Minutes* effectively censored themselves and I couldn't even buy the archived footage from them!

This Safety Alert booklet is meant to be very short and isn't meant to cover—even in an abbreviated fashion—many of the main relevant topics. A full coronavirus report is in the works. But there should be more than enough here for anyone who is considering taking a coronavirus vaccine to begin the process of reconsideration!

## Chapter 1: INFORMED CONSENT

---

Hospitals and medical offices and pharmacies are trained in medical informed consent; they're trained to give the patient a watered-down, dumbed-down information sheet when they administer a vaccine, for instance. The patients agreed to an unknown—that's not truly informed consent.

Nurses: have you ever read a package insert for a vaccine? It's that great, big, folded multi-page warning with tiny font (it must be smaller than size 8 font). Did you ever notice that it says some very different things than the one-page patient information sheet—some disturbing things that don't encourage much confidence in the safety of the product?

For a patient to be able to give informed consent, there are two things that must happen: they should be informed about the risks and ostensible benefits of the intervention, and they should be able to refuse. Rape doesn't involve consent. The simple fact is that many nurses have serially raped the medical informed consent of their patients without even realizing that they were doing so.

We live in the United States of America. This country is supposed to be a free one, even the world's example of freedom. Disastrous cases like *Jacobson v. Massachusetts* (1905) set a precedent as much as 115 years ago (in this country) which, sadly, lingers with us to this day. When the body of a person is owned, that is full slavery. This is shown clearly in my book (required reading, but for the sake of speedily warning you people about the dangers of vaccinations I am merely asking you to start with the vaccines chapter first).

In the aftermath of the Second World War there was the NAZI Doctors' Trial, and one result of that proceeding was the establishment of the Nuremberg Code. Here is a little excerpt just from the first three lines of this short document:

The voluntary consent of the human subject is absolutely essential.  
This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion;... [4]

Does that sound anything like the United States of America today? No force? No duress? No over-reaching? No coercion? Even if you're not aware, yet, of the fraud and deceit, you should agree that this mirror from history that we're looking into is not reflecting back to us favorably. This Code was made, to my understanding, to address the topic of medical experimentation specifically. I do briefly argue that vaccinations are always experimental in my 2019 letter to the Oregon legislature (please see the Open Letters section of my website for this). I repeat: The US Supreme Court, in the year 2011, repeatedly called vaccines “unavoidably unsafe” and said this was a good reason to further remove civil liability from pharmaceutical companies in the realm of design-defect claims, claims which allege that the company could have made a safer product. [5] SC Justices Ginsberg and Sotomayor were the dissenters in that case. When Justice Ginsberg died recently and the media covered her career somewhat and mentioned her dissenting opinions, why didn't they mention this one?

What if the news media said tomorrow: "You're free in the USA because the government owns your body and your children." ? Would you agree? Nowhere is medical informed consent violated more than in the fields of immunology, psychiatry and oncology, and the field of immunology hasn't ever had a more conspicuous influence on our nation than it has today during the lockdowns.

The only vaccine exemptions/vaccine waivers expert in the USA in North Carolina's Alan Phillips, JD. His website is [www.VaccineRights.com](http://www.VaccineRights.com), and for any health care workers looking to keep their jobs a consultation with him would be the only thing I can recommend at this time. Counsel Phillips has been very successful at obtaining waivers/exemptions for nurses, and they can still keep their jobs. My take on the behavior of hospitals, generally, from learning about the great work of Counsel Phillips, is they've been intimidating their nurses and pretending that the nurses must take vaccines or else be fired—at least until they're slapped with the Federal Civil Rights Act. Unless I have misunderstood some part of his work, the hospitals have been pretending that it is the law for nurses to take vaccines and that no exemptions are allowed; exemptions are allowed though none are offered. Nurses and other medical staff should not be bullied into compliance with a non-law (and any bad laws should be repealed). Many hundreds of individuals have worked with Alan Phillips (and many of these have been nurses).

For those in the military: There is an article by Children's Health Defense which covers this question, and Counsel Phillips told me that this one is mostly not inaccurate (though it is incomplete). [6]

Note: A previous article on CHD about military exemptions was said, by Counsel Phillips, to be inaccurate. I've been trying to get CHD connected with Counsel Phillips because I believe they should be collaborating rather than working in isolation.

In my opinion it would also be a righteous practice for nurses to refuse to administer coronavirus vaccines (or any other vaccines); it's not enough to refuse to take the shots. It will have to be done in such large numbers that the hospitals, clinics, etc. just can't find anyone to hire who would administer the shots, since the whole public would be aware of the dangers and therefore unwilling. The time for that is now; there has never in history been a time when public trust in vaccines is lower than it is now. And they can come out on the TV with fake surveys and say that public trust in the coronavirus vaccine is climbing 2% or 5% or 10% at a time, but I won't believe it for one second. Everywhere I look in my own life, public trust in vaccinations is (thank G-d) being eroded, and I hear more and more from people who weren't previously interested in or concerned about the topic that they will not be taking the coronavirus vaccine or other vaccines.

It's different with an emergency declaration: The exemptions information supplied above only really works under the assumption that there is not a declaration of a pandemic/a declaration of emergency in the USA; the law in the USA (which needs to be changed to favor medical freedom) essentially allows governments to do whatever they want if an emergency is declared (in the realm of health and elsewhere). Alan Phillips JD saw this coming years ago and launched the Pandemic Response Project (PRP) in an effort to pass better legislation that would preclude that kind of destruction of liberty (and of the physical health of mankind). I still recommend him as the top vaccine exemptions/waivers attorney of the USA but I think in the face of the current government over-reaching another approach has to be used: strength in numbers. In fact, if individuals are singled out by hospitals/clinics etc. for vaccination and their jobs are threatened, they might feel pressured to cave in. This is likely the tactic that will be used by unscrupulous administrators, if good administrators have been removed and replaced at any time. But realistically, the hospitals and clinics cannot afford to instantaneously fire, hire and train 60% or 70% of their nursing staff,

for instance. This is true even in hospitals where nothing is going on; it's not only true for a busy hospital. Obviously the same thing is true for other types of medical personnel, for emergency responders, for police officers and firefighters and military servicemen and EMTs, etc. The surveys I have heard about reported in the mainstream news in the last few days have shown that only around one third of medical personnel would be willing to take the coronavirus vaccine. The mainstream media lies all the time, so maybe the real numbers are very different—then again, “a broken clock is right twice a day,” as it is said. One third are refusers. So that leaves one third undecided, certainly meaning that they are in the hesitant category. This Safety Alert booklet is for all three groups, because the refusers simply need to inform the people who are hesitant or planning to take the shots.

Dear nurses and doctors and other health care workers:

Do you remember the opioid crisis? Do you remember that the media wanted us all to be outraged about it? A lot of money certainly was involved. There can be no doubt that a lot of people were hurt and killed. Why would anyone say in their hearts, “Pharmaceutical companies are evil and corrupt—oh, except when it comes to vaccinations. When it comes to vaccinations, they're angels and they're perfectly honest.” ?

Others have come before me and pointed this out. One such example comes from the LETTERS department of the Fall 2019 issue of *Wise Traditions*, the journal of the Weston A. Price Foundation:

INSANE

There is so much in the news right now about the irresponsibility and gross negligence of pharmaceutical companies surrounding the opioid crisis—seventy-six billion pills and over one hundred thousand deaths in a seven-year period. The public is outraged, Congress is outraged...and yet this is the same industry that can do no wrong and is being completely vindicated over the “safety” and “effectiveness” of vaccines. It’s insane.

The media and the government would like us to have amnesia about this at a time that seems convenient to them. They'd like us to forget that everyone of every political persuasion is now aware that “Big Pharma” is corrupt.

Brian Wort did a good job explaining that one. Robert F. Kennedy, Jr.—the Kennedy who generally isn't allowed by the lying networks to speak on television because of the kind of work he does—has some more to say on this topic. Here's what he said in an interview with the Weston A. Price Foundation (my emphasis in bold):

**...These four companies are all convicted felons—Sanofi, Pfizer, Merck and Glaxo [that is GlaxoSmithKline]. Those four companies, in the last ten years, have paid 35 billion dollars in criminal penalties, civil penalties and damages for falsifying science, for defrauding regulators, for lying, cheating, stealing, bribing, blackmailing doctors—and they get caught. Time after time they get caught—killing hundreds of thousands of Americans. Merck, which is the biggest vaccine maker in our country, in 2006 paid 7 billion dollars on Vioxx for killing between 120,000 and 500,000 Americans with a drug that they marketed as a headache pill that they knew caused heart attacks. They knew it because in their clinical trials they saw that a lot of people were dying from heart attacks. And they went to the bean counters; the bean counters said, even if we kill these people, we're still going to make more money—even if we have to pay them all off. So they went out with this drug. Now the people who were getting that drug, who were taking Vioxx, did not know that it caused heart attack because Merck kept that a secret. And so: what makes you think that these companies, that the morality that you imagine these companies have, would attach itself to vaccines, but not all the other drugs—where they can get caught, because you can sue them...? Vaccines are the only place they can**

never get caught. No matter how negligent they are, no matter how malicious, no matter how toxic their ingredients, how egregious your injury—you cannot sue that company. And the only reason they got caught for Vioxx and all these other drugs is because private plaintiffs attorneys sued them on behalf of an injured party and then, during the discovery process, they stumbled across documents that showed they had violated criminal statutes, and the attorneys walked those documents down to the US Attorneys' office and said, you should prosecute these guys criminally. But that could never happen with vaccines. And, in fact, it's a good thing for them to injure as many people as possible. Those companies are making 60 billion dollars a year selling these mandatory vaccines. They're making 500 billion selling us the EpiPens, the albuterol inhalers, the diabetes medications, the rheumatoid arthritis medications, the anti-seizure medications. And all of these medicines—if you look at their top 20 drugs, **blockbuster drugs** for these companies—virtually all of them **are targeted to treat diseases that are listed as side effects of the vaccines on their own manufacturers' inserts.**

HLG: So they make us sick, and then they try to sell us the cure.

RFK, Jr. : It's the perfect business model. If you get measles or chickenpox, what's the cure? A week in bed and chicken soup and vitamin C. You can't patent any of that. Nobody is making money on it. You don't even go to the doctor. I had eleven brothers and sisters and we all got chickenpox. We all got measles. We never saw a doctor. We just got it, we had chicken soup and vitamin C, and that was it—and we went back to school. But if you can give that kid an MMR shot that gives you Guillain-Barré [GBS is the type of paralysis which Judy Roberts, the lady featured in the 1979 60 Minutes segment, got from the 1976 Swine Flu vaccine] or gives you seizures or epilepsy for life—now you have a lifetime customer. Or narcolepsy from the flu shots. So those companies have the perfect business model. They have a mandatory drug that they can [use to] make us all sick. A mandatory [drug] that's given to healthy kids to make us all sick, and then they sell the treatments for the rest of their lives. I've got kids who are going to be buying EpiPens until the day they die—\$600 EpiPens. [8]

The truth is that the pharmaceutical companies are serial felons. They consider it just the cost of doing business to knowingly kill large numbers of people. They have a product which was indemnified by the 1986 Childhood Vaccine Injury Act, which has paid out over 4 billion dollars in damages since it formed the National Vaccine Injury Compensation Fund. They have special indemnity in the case of the coronavirus vaccine because of the emergency declaration that was made, so it appears that nobody will be able to sue for damages and deaths caused by the new coronavirus vaccines—that makes it the perfect business model, even more so than it already was.

So what are you going to do, nurses and health care professionals? Are you going to trust these same companies with your life and with your health?

Doctors and nurses are hammered in school with the concept that “peer-reviewed medical journals” are everything and that academia, as we know it today, is very trustworthy. If a medical student is paying attention and trusts the information presented, he will be made to believe that corruption is exceedingly rare in the medical literature and the scientific literature in general. There are so many ways to prove that this is not true. Just a few are presented below.

As it turns out, there are 19 studies in the relevant chapter of Neil Z. Miller's latest book, *Miller's Review of Critical Vaccine Studies | 400 Important Scientific Papers Summarized for Parents and Researchers*. That chapter is called “Conflicts of Interest, False Studies and Industry Control” and it is an eye-opener. This is definitely recommended reading (but the reader of this Safety Alert booklet already knows that because he has surely already read the vaccines chapter of my book, which is free).

My 2019 letter to the Oregon Legislature (available at the Open Letters section of my website) does not do such justice to the topic as Neil Miller's chapter, but it covers it enough that I've pasted some relevant pieces below for the benefit of the reader (I'll quote myself in quotation marks “”):

“Phase IV clinical trials have been, in fact, a type of medical experimentation which include post-marketing surveillance for harm. [10,11]

“For this reason it might be argued that the Nuremberg Code (which addresses the topic of medical experimentation) does provide for health freedom in all circumstances, even during phases which the existing official news platforms have not considered to be experimental. The majority of the death and health harm caused by the drug Vioxx was during the post-marketing surveillance period. Osteopathic physician Joseph Mercola DO says that he had given early warnings of the great harm which surely would be caused by putting that drug on the market, [12] because of the preliminary studies done by the drug company itself. In my opinion and in the opinion of others (i.e. Marcia Angell), this and other types of fraud have been extremely common in the pharmaceutical industry. But it is not even necessary, for the purposes of this letter, to prove fraud in the medical literature. Just take the words of Marcia Angell, Richard Horton, and John Ioannidis which show that the peer-reviewed medical literature is simply untrustworthy. I argue that untrustworthy research cannot possibly be the foundation of any sound public health policy—including and especially vaccination policy. An October 2015 article [13] in the *Canadian Veterinary Journal* explained the positions of Drs. Angell and Horton, respectively, as follows:

“It is simply no longer possible to believe much of the clinical research that is published, or to rely on the judgment of trusted physicians or authoritative medical guidelines. I take no pleasure in this conclusion, which I reached slowly and reluctantly over my two decades as editor of *The New England Journal of Medicine*.” [14]

More recently, Richard Horton, editor of *The Lancet*, wrote that “The case against science is straightforward: much of the scientific literature, perhaps half, may simply be untrue. Afflicted by studies with small sample sizes, tiny effects, invalid exploratory analyses, and

flagrant conflicts of interest, together with an obsession for pursuing fashionable trends of dubious importance, science has taken a turn towards darkness.” [15]

“The *Canadian Veterinary Journal* concludes:

The take home message is that readers must exercise caution in interpreting the published literature, regardless of the reputation of the journal in which an article is found. [13]

“Richard Horton also wrote the following in his piece in *The Lancet*:

“A lot of what is published is incorrect.” I’m not allowed to say who made this remark because we were asked to observe Chatham House rules. We were also asked not to take photographs of slides. Those who worked for government agencies pleaded that their comments especially remain unquoted, since the forthcoming UK election meant they were living in “purdah”—a chilling state where severe restrictions on freedom of speech are placed on anyone on the government’s payroll. Why the paranoid concern for secrecy and non-attribution? Because this symposium—on the reproducibility and reliability of biomedical research, held at the Wellcome Trust in London last week—touched on one of the most sensitive issues in science today: the idea that something has gone fundamentally wrong with one of our greatest human creations. [15]

“Later, when you Members of the Committee read the Children's Health Defense letter [16], you will learn that John Ioannidis stated in his legendary 2005 paper that:

There is increasing concern that in modern research, false findings may be the majority or even the vast majority of published research claims. [17,18,19] However, this should not be surprising. It can be proven that most claimed research findings are false.

“I hold that nobody should be forced to participate in medical experimentation or forced medication of any kind. And how much more reasonable is this opinion of mine in the light of what these editors of prestigious journals (*The New England Journal of Medicine* and *The Lancet*) and the very well-respected John Ioannidis have said about the medical literature—that it is extremely untrustworthy?”

Those who do not yet know about the long-standing policy of defrauding the public with fake medical research papers in the scientific journals should watch *The Oiling of America*, which is a terrific DVD made by the Weston A. Price Foundation. It's available at New Trends Publishing but also can be viewed for free by the public on the YouTube. [20] Explicit permission of the WAPF President for the free viewing of this presentation has already been obtained. In that DVD, President Sally Fallon Morell shows that lipid chemist Mary Enig PhD of the University of Maryland was blackballed for showing the great dangers of trans fats. The industries were heavily involved with the lipids department there. Dr. Enig was able to publish one study on the dangers of trans fats, and when she did so it caused journal editors to become enraged that they hadn't been able to keep her study from being published. This was many years before trans fats were well-known in this country to be extremely harmful to the human body, as Dr. Enig was a pioneer in this area.

As explained in *The Oiling of America*, the editor reportedly told Dr. Enig (I'm paraphrasing):

...I thought my colleague was watching his journal and I was watching mine, but we left the barn door open and a horse got out. This will not happen again... [20]

And Dr. Enig never received “another penny” of funding for her research. It is made very clear in *The Oiling of America* that heart disease, coronary artery disease, is primarily the result of the introduction of the deadly industrial seed oils (so-called “vegetable oils”) into our food supply. There are also plenty of other factors involved, including but not limited to a large variety of nutritional deficiencies. But the message is clear: “vegetable oils” (deadly industrial seed oils) are the primary cause of heart disease.

So, doctors and nurses and other health care workers: how is that statin drug and low-fat diet strategy working for the patients? We can see how it's working. Heart disease rates have continued to climb for many decades now—it's really getting close to 100 years already since it came on the stage in America. We have all kinds of elderly Americans that are suffering from statin-induced Alzheimer's disease, erectile dysfunction, cancer, type II diabetes, extreme muscle wasting and muscle pain and collapsing backs due to the damage to the small muscles in the back, heart failure (i.e. since the heart muscle requires a lot of coenzyme Q10), mood problems and rage, peripheral neuropathies and mitochondrial DNA damage from the statin drugs. Years ago I became concerned about statin drugs, having seen many people who were severely damaged by them, and I then bought five books on the topic. Among those books were:

- (1) *How Statin Drugs Really Lower Cholesterol: And Kill You One Cell at a Time*—James B. Yoseph and Hannah Yoseph MD
- (2) *Poisoned!: Recovery From Statin "Side Effects"*—James B. Yoseph and Hannah Yoseph MD
- (3) *Lipitor: Thief of Memory* by former NASA flight surgeon Duane Graveline MD
- (4) *The Statin Damage Crisis* by former NASA flight surgeon Duane Graveline MD

The statin drugs are truly a bestseller today, and they were brought to market (as shown by these books) through fraud. My conclusion is: the medical literature is untrustworthy; those setting the “standard of care” are untrustworthy; there are very many individual doctors and nurses who are well-meaning but who are causing enormous damage to patients simply by believing what is published in the medical literature and by believing that the “standard of care” they have been instructed in is a good idea. In my book there is some more discussion about “standard of care” and how it prevents innovation.

## Chapter 5: WHAT ABOUT THE VIRUS?

---

*In my opinion as a Health & Homestead Consultant (non-accredited),  
Americans, then, are actually getting worse so-called “medical” care  
than the tens of thousands of chickens packed into one barn,  
never seeing the light of day.*

For years I have been increasingly skeptical about the real usefulness of the germ theory of disease transmission. I guess it all started back when I learned about a study that showed that the essential oil of oregano was good at killing the water-borne *Giardia lamblia*, a pathogen known to hikers. I learned from that study that the essential oil of oregano was as good at killing *Giardia* as the “standard of care” pharmaceutical drug which is frequently used by allopathic doctors (I use the term “allopathic” because there are, in fact, other kinds of doctors). The basic truth is: G-d made natural medicines and He made them right the first time; they're not patentable, and they cannot make a lot of money. Allopathic doctors—which have “legislated themselves into a protected monopoly,” in the words of Joel D. Wallach DVM ND of *Dead Doctors Don't Lie*—use patented drugs. They might even use generic drugs, too, but they use pharmaceuticals and technologies and man-made stuff. Note: Later, I learned from the work of Bruce Fife, ND (the world's leading tropical oils expert) that coconut oil is good at killing *Giardia*, which makes sense to me because it is such a good antimicrobial food. I would consider it far more gentle than essential oil of oregano, so it would be a better choice for dealing with a case of *Giardia*.

So I later learned, as it is shown in my book, that raw milk works splendidly for eye infections when dropped right into the eye (coconut oil is good for this, too, according to Dr. Fife). I learned that Manuka honey is being used for surgical mesh as an antimicrobial (it should be \*raw\* Manuka honey or any raw honey, truly unheated—not heated beyond 93 degrees F) and that probiotics are now being used by the forward-thinking MDs for wound care instead of antibiotics. I learned that raw honey can release hydrogen peroxide as needed and that many pathogens can't live in the presence of oxygen (tetanus is a good example). So those puncture wounds for which allopathic doctors (and nurses) are typically pushing tetanus vaccines should actually be treated with an injection of raw honey to the area, not with a criminally-injurious vaccination. I learned that food really is the best medicine for the body, and I saw that my own health was improved with the Weston A. Price Foundation diet. I even was able to reverse many cavities in my own mouth with very careful adherence to their dietary principles—so go ahead and add me to the list of people who will testify that *Cure Tooth Decay* and *Cure Gum Disease Naturally* by Ramiel Nagel (books written according to WAPF principles) helped to remineralize many cavities. I had dozens of cavities but now I have fewer (and I've never had a filling, thank G-d for that)(and the tooth decay has halted; there is no active decay). Look, I'm not going to rewrite my whole book here for you, but you should know that the healing power of real food is not a joke and it is not wimpy or weak. There are plenty of dentists out there who have been trained that cavities cannot be reversed with food—that's just part of the standard training! And there are still some dentists placing mercury amalgam (“silver”) fillings! After all of these decades, the Amalgam Wars aren't over! One possible good news item there: even the criminal FDA recently issued a warning this year that mercury amalgam fillings aren't safe.

I also learned that antibiotics are tremendously harmful for the body; not only do they destroy the beneficial microbes in the gut, but they cause learning disabilities in the children of mothers who

take them (according to Russian neurologist Natasha Campbell-McBride MD) and they even destroy the mitochondrial DNA (mtDNA), as shown in an excellent article by Wayne Feister, DO in the Fall 2019 issue of Wise Traditions, the journal of the Weston A. Price Foundation. [21]

Doctors generally don't tell patients today that antibiotics can cause permanent DNA damage because that's not part of their training; if they know about it, it's because they have gone very far outside of their training and done learning on their own, the only way they can be good doctors.

I also learned that the “official” US health agencies have been saying that the year 2020 is the beginning of the “post-antibiotic era” (their terminology, not mine). That era should be exactly what it sounds like, because the fact remains that non-pharmaceutical treatments for infectious diseases have been around for as long as people have been around (since G-d made them); these are more effective than pharmaceutical treatments and they occur bountifully in great variety in every part of the world. However, the agencies have been saying that the “post-antibiotic era” would be a time for eliminating antibiotics from feedlots (confinement animal feeding operations) and discouraging routine administration of them in people and, of course, developing new pharmaceutical antibiotics. I'd like to see them act on the true knowledge that this pillar of the germ theory has failed.

So I should mention that I also learned that raw milk is the safest unfermented raw food. It has about 20 living antimicrobial factors in it that are very effective at killing pathogens and are very effectively killed by heat. This is explained very well in the presentation “Raw Milk Safety” from a FARFA conference in 2009 which has been made available free to the public on the YouTube by permission of the Weston A. Price Foundation:

Raw milk, raw cream, raw butter and raw cheeses are legal in the ordinary grocery stores now in California—this might be just about the only law I've heard of in that state that I like. Raw milk vending machines are all over Europe; many countries have them. Illnesses attributed to raw milk continue to decline as raw milk consumption continues to rise. The Real Milk Finder is a terrific listing of places to find raw milk in all 50 states.

I also learned that a raw milk enzyme called lactoferrin is used in the meat-packing industry to make the food safer.

I also learned that there are industrial confinement chicken houses (the big brands) which are now using “thyme in the feed and oregano in the water” (and they now use no antibiotics ever). I'm starting to think this may be because the health agencies told the CAFO animal operations that they

aren't allowed to use antibiotics anymore (in light of the “post-antibiotic era”). In my opinion as a Health & Homestead Consultant (non-accredited), Americans, then, are actually getting worse so-called “medical” care than the tens of thousands of chickens packed into one barn, never seeing the light of day. Note: Thyme and oregano can be harsh (and might possibly reduce the numbers of the beneficial microbes in the gut) so they might not be the first place I'd start for helping a sick person. Raw liquid whey and raw skimmed milk would be excellent for the birds, and they need to be raised on pasture, not in confinement (let the people eat the raw cream, butter and cheese!).

In short, I've been learning over the years that natural medicine is actually stronger than allopathic medicine, and it's cheaper since it cannot be patented. I've seen it firsthand so many times that it is now, to my thinking, accepted as a “given” that it is superior. G-d gets all of the credit for this, because it is a certainly a simple, foundational principle in Orthodox Judaism (I'm a righteous gentile/a Noahide) that “G-d creates the solution before He creates the problem.” As a naturalist, I personally interpret that to mean—in the field of health—that G-d creates the natural solution before He creates the health problem. There is much more about this explained in my book.

### **Personal responsibility:**

As a result of this simple and true understanding, I have lost my fear of germs. They're not scary to me anymore. If there is something out there which can be transmitted, then it is not something I personally have to worry about for the sake of my own health. It's not impossible that somebody else might get some germ, but that would be their fault. The germ theory, if there is some real validity to it, is about personal responsibility—and not in the way the media and the allopathic cartel have been trying to force us all to believe. Personal responsibility is not about obsessively washing the hands, using hand sanitizer until the hands are red and raw, wearing masks, never seeing your grandmother again, wearing a space suit and all of these things. They would have us believe that the answers are complicated and technological and required specialized experts when the reality is that the answers are simple and natural and made by G-d and usually require no particular expertise. Real personal responsibility means a person should be able to have people coughing and sneezing all over them—with big globs of snot flying everywhere—and not have a problem. If a person gets right with the G-d of Israel and is well-nourished and well-rested and not exposing him/herself to poisonous environmental factors (such as vaccinations, pharmaceutical drugs, wireless internet, cellular telephones, chemical poisons in the food/water/air etc. etc.) then he or she will not have a problem with the “infectious” diseases.

### **A tiny sample of information about the coronavirus and coronavirus vaccines:**

A pathologist petitioned FDA to halt Pfizer vaccine administration until efficacy is proven. [22] A great number of people have signed the Great Barrington Declaration; when last I checked at least 45,000 doctors and scientists signed it along with at least 600,000 non-experts. [23] Here is the FDA PowerPoint slide [24] listing the the 21 serious conditions and death which the FDA is looking for as adverse events caused by the coronavirus vaccines:

- Multisystem Inflammatory Syndrome in Children
- Vaccine enhanced disease

From that list, we've already seen at least transverse myelitis [25] and multiple sclerosis (MS would fit in the category “Other acute demyelinating diseases”). We have also been more than sufficiently warned in the Vaccination Updates department of the Summer 2020 and Fall 2020 issues (these are required reading in the chapter 'ACTION SUMMARY') of *Wise Traditions*, the journal of the Weston A. Price Foundation about the very great danger of “pathogenic priming”/“vaccine enhanced disease”/“paradoxical immune enhancement” (these interchangeable terms all mean that the vaccine makes the person much sicker once “infected” than if they never had the vaccine, and this seems likely with the coronavirus vaccines, according to Kendall Nelson, the author of those Vaccination Updates, in light of the history of the attempts at SARS vaccines and vaccines against another virus called RSV). Have the vaccine makers tested the trial participants to see if this phenomenon would occur by intentionally making them sick with “coronavirus” after administration of the vaccines? No. Surely they'd argue that would be unethical. Acute neuro-encephalopathy was reported in one of India's AstraZeneca vaccine volunteers. [26]

Brazil's President says he will refuse the coronavirus vaccine, [27] and he warns his nation that the Chinese vaccines are dangerous. [33]

Parents have been enrolling children in coronavirus vaccine trials. [28] Developmentally-disabled people are being targeted for vaccine trials. [29] Journalist Sharyl Attkisson is publishing her book *Slanted* this month—it's a book which shows that the media is run by the government instead of the watchdog of the government (its original duty). [30] Holocaust survivor Vera Sharav now warns, through her organization AHRP, that the CDC is proposing concentration camps for coronavirus in a new document; the document calls for invading homes and separating families. [31] Mrs. Sharav has been a long-time proponent of medical freedom and has produced a wealth of excellent material. Two airlines are recommending vaccine passports. [32] Mercola.com (platform of Joseph Mercola DO), Children's Health Defense (platform of RFK, Jr.) and National Vaccine Information Center websites (NVIC, Barbara Loe Fisher's platform) have been named national security threats. [34] Not only the mentally retarded children but also the ethnic minority groups have been targeted for the first vaccines. [35] CNN says that vaccination cards will be issued to everyone getting the coronavirus vaccines. [36] The Moderna vaccine has a 20% serious injury rate in the high-dose group. [37] Moderna previously admitted that components of their shot could lead to serious adverse events, including the lipid nanoparticles (LNPs) and polyethylene glycol (PEG). [38]

A doctor has said that people who don't wear masks are like “enemy combatants.” [39] There have been many anti-lockdown protests across Europe; these have involved enormous numbers of people. [40] Recent protests in Denmark led to the abandonment of a forced vaccination law. [41] Journalist Del Bigtree, Dr. Mercola and others have explained that the Pfizer claims of 90% efficacy are suspect, to say the least. [42,43] It appears that the government of the UK is trying to build an artificial intelligence system to count vaccine injuries and deaths. [44] Elon Musk tested positive twice and negative twice in same day, disagrees with the lockdowns and won't likely be getting the vaccine. [45] In my home state of Oregon, it was proposed to tie the coronavirus vaccination with socialist welfare state “benefits.” Former Vice President Biden's coronavirus task force appears to be interested in the same thing. [46] Ticketmaster plans to track vaccination status of attendees with so-called “smart” phones [47]; I thank G-d that I don't have any cellular telephone (or wireless internet for that matter). New Zealand has quarantine centers which some people (people like me) are referring to as “camps.” [48-53]

Perhaps the New Zealanders from the last article haven't heard of Prora, the 3-mile-long vacation getaway/national socialist dormitory built by Hitler for Germans to enjoy. [54] There may be a secret quarantine camp in Manitoba, Canada. [55] A microphone was cut off when a Canadian politician spent too much time asking about who may be detained at the quarantine/isolation camps in Canada. [56] A CIA-linked defense contractor is involved in a coronavirus vaccine trial. [57] Johnson & Johnson is another company that had to pause its vaccine trial. [58] Reportedly, the New England Journal of Medicine has published recommendations that coronavirus vaccine refusers should be locked in their homes and fired from work. [59] Even CNBC has now reported extreme side effects from the Moderna and Pfizer coronavirus vaccine trials. [60] Police in Australia have been granted the power to strip people bare, including the removal of underwear, in order to give them vaccinations. [61] An Ohio woman was shocked with a taser for refusing to wear a mask at an outdoor sporting event, and for the record she was more than 6 feet away from others. [62] According to ZeroHedge, Yelp reviews indicate that 60% of businesses are permanently closed. [63] “Uncooperative” citizens will be isolated in a quarantine facility, says Quebec City, Canada. [64] Dr. Mercola has published an article showing that influenza vaccine (flu shots) might double the risk of coronavirus. [65] Hawaii now has mandatory coronavirus testing checkpoints. [66] The Virginia state health commissioner says he will mandate the coronavirus vaccine. [67] The Detroit Lions plan to require players to wear microchips to track who they are around. [68] It seems that Mastercard and GAVI have decided to partner in order to roll out a cashless money system and merge it with vaccination status. The implication is that unvaccinated people would be disallowed from buying anything. [69] A Louisville couple was put under house arrest and forced into ankle monitors for not signing some coronavirus documents. [70] GlaxoSmithKline decided to re-use its highly-injurious oil-based adjuvant ASO3 for its coronavirus vaccine candidate, despite the fact that everyone knows it caused a lot of narcolepsy. [71] As expected, 'kidnap quarantine' as I call it has been recommended by the World Health Organization, the WHO. [72] Very significant dangers of coronavirus vaccines have been known for over a decade, ever since the SARS vaccines were attempted. [73]

Folks, there is so much more that could be added to this section. After having taken about 100 pages of notes since before the lockdowns began, I can say that it's very likely I haven't even included a small fraction of the very most shocking headlines here. Please remember this Safety Alert booklet is meant to be very short and that its main purpose is to direct readers to other sources, not to stand alone.



Folks, you need to know that strip clubs have been left open in California (the 1<sup>st</sup> Amendment has been cited in support of that policy) and at the same time houses of worship have been fighting for the right to stay open (and the 1<sup>st</sup> Amendment has been trampled on in order to make that policy happen). [74] Garden centers were ordered cordoned off in Michigan in the name of stopping the spread of the illness but the grocery stores were allowed to remain open (it should be so obvious to all that growing one's own produce would be “safer,” in the context of any “real” contagion, than buying produce at a store). [75] It is becoming very clear that the story we've been told by the government-approved media doesn't accurately reflect reality.

I'll skip everything else for now and just explain something to you readers: at a time when the university systems have typically been claiming (and trying to instill in their students) that there are far “too many people in the world,” there are also efforts at reducing the population. Many such efforts are openly-admitted efforts, but I make a strong case in my book that many have not been made public. It would be easy for those involved to think they're doing something 'moral' by taking covert steps to reduce the world's population, but that is proven false in the book, thank G-d. There is a great deal of evidence that injectable contraceptives have already been tested on unwilling people, i.e. in the USA and in India and in Africa and in the Philippines, for instance. This is covered to some extent in my book and also is covered in the work done by the Weston A. Price Foundation and Children's Health Defense and others. As expected, these injectable contraceptives have, in fact, been vaccinations. National Security Study Memorandum 200 (1974) [76] talks a great deal about this for both men and women and the UN's own document from the early 1990s shows they were developing an injectable contraceptive that would result in the production of anti-hCG antibodies, rendering the woman incapable of carrying a baby. Many thousands of girls suffered severe adverse reactions to the HPV vaccines Gardasil and Cervarix and a large number of these girls went into menopause as teenagers. It appears that in India the situation has been even worse (WAPF and CHD covered this well, and so did G. Edward Griffin's news platform NEED TO KNOW). I won't copy here all of the related materials from my book, but will simply direct the reader to the book so the references can be checked from there.

There are other motives to consider. Certainly there is a profit motive; if large numbers of people are made ill by a pharmaceutical product for which there is no liability, then they might be expected by the industry to become life-long patients supplying a very steady flow of revenue. If neurological and autoimmune disorders are induced, so the logic goes, the injured parties will pay huge amounts of money to those same companies—for life. Later in this Safety Alert booklet, RFK, Jr. is quoted on this point.

The simplest motive, however, really is the right one: establishment of a global dictatorship through securitization of health. We've been told that it's a matter of “national security.” We've been told that the deaths from the virus are “like a 9/11 every day.” Surely, then, anyone who might dissent from their official narrative would be painted as a terrorist, if they might be also painted as responsible (in one way or another) for a piece of the pandemic which has been said to be “like a 9/11 every day.” Later in this Safety Alert booklet we will see, in general terms, why this all happened in our great country, the United States of America.

Nursing school, like the college/university schooling which preceded it, necessarily demands com-

plete illiteracy in news items on the part of the student. Medical school is the same. And once the student becomes a practitioner, there is even less time for learning about what is really going on in the world, and the majority are expected to turn to the mainstream (government-approved) news media at some point in their lives if emergencies arise or if they begin to feel uninformed. The lock-down of control of the information is one of the goals of the government response to this bad breathing illness, and it is the force that has been continuing the tyrannical standard of care, a standard which cripples real innovation both for infectious diseases and for other health problems. One UK whistleblower claims that 97% of women might be sterilized by coronavirus vaccine adjuvants. [77] I don't know for certain if that's true, but I know it is very plausible.

G. Edward Griffin has stated [78] that the Milgram experiments predict the behavior of obeyers of authority in the coronavirus emergency. I think it would be wonderful to learn from that part of history by not repeating the same kind of mistake! The Milgram experiments were not about testing the effects of electric shocks on victims but were instead a behavior experiment. The organizers decided to watch what would happen if they ordered volunteers to press a button to shock other volunteers with progressively stronger electric shocks, causing pain to the people who were shocked. The final endpoint was that the ones volunteering to press the button were told that the electric shock would kill the other volunteer. Many pressed the button after being told that it would kill! They protested and complained, but ultimately did it. So goes the story of the Milgram experiments. This was a short time after World War II, a war very famous for the NAZI medical experimentation. Human authority has mattered too much to a lot of people, it seems, and I urge you readers to consider the extremely perilous stage of US history we have now reached!

The frequently-slandered but vindicated-in-court Dr. Andrew Wakefield recently did an interview with Mike Adams, the Health Ranger. The interview [79] was a good one and lasted about an hour. It included the following information (approximate timestamps are given):

DR. WAKEFIELD: ...we will never have adequate safety data on these [coronavirus vaccines]. And even more alarmingly, we saw the vaccines producing serious neurological adverse reactions—transverse myelitis, multiple sclerosis—and yet, they were allowed to continue. My prediction for this, Mike, based upon all the work I've done over the years and my latest film, *1986: The Act*, is that these vaccines will have at most a 6-month lifespan before it becomes so abundantly clear that they are harming, that they will be stopped. And I agree with you; I listened to you on a show the other day and you said, “These adverse reactions will be ascribed to the disease,” to “COVID,” not to the vaccine, but I do think that the spectrum of injury caused by the vaccines will be different from that of COVID itself—and therefore they will stand out; they will be largely neurological and autoimmune. So I think that what we're going to see is rather like the Swine Flu vaccine of 1976 for a fake pandemic, for a mistake—a clear mistake—by the CDC. We are going to see a vaccine with a limited lifespan but it's going to hurt a lot of people...we're going to see the accumulation of a large number of injuries and deaths to the point where it becomes self-evident. So what will be the turning point, I think, is shows like yours bringing attention to the fact. It certainly won't happen in the mainstream media to anything like the same extent, but it will happen in the alternative media where people not only experience injuries themselves or in their families or in their communities, but they then go searching for sources such as yours which give them, bring them the truth about vaccine injury, and, yes, that will lead to a totally unnecessary delay in the acknowledgment of the injury but I think, ultimately, from the ground up, people are going to just vote with their feet and say, “Enough is enough.”

MIKE ADAMS: But the second question on that is: how would the general public even become aware of things like that given that sites like mine—I was among the very first to be completely blacklisted by Google and YouTube and all the platforms, which is why I had to build my own platforms like this one [Brighteon, a censorship-free alternative to YouTube]. But it seems like the powers-that-be can cover up the injuries for quite a long time—especially with Facebook now saying that they are going to self-anoint as the vaccine authority now, no doubt with input from the WHO, United Nations and probably Bill Gates as well, but you're not allowed to say that somebody was injured by the vaccine.

DR. WAKEFIELD: And what's happening now—autism is an example of this, that they denied and denied and denied and continue to deny that autism is a consequence of vaccination. But now it becomes so self-evident; so many children are damaged; the numbers are so great that it starts to impact the school budgets—they can't have classes for excellence, they can't have sports programs. So much money is now being devoted to the creation not just of classrooms for children with autism and other developmental disorders, but schools—actual schools—to cope with these individuals. And so it has now pervaded communities that they have been lied to, that there is a problem. And this is why we're winning. And this is a really important point, Mike, is that you know from that recent World Health Organization

meeting: they're saying, "How are these anti-vaxxers so effective? Why are they gaining such traction? They must have huge funding. They must be incredibly well-organized." No. We have the truth on our side, but more importantly: there is a tragic level of injury that is pervading communities and the American people aren't stupid; they know what's going on. And now the tide is turning against vaccination. And I think what we're seeing with COVID is a "hail Mary" pass—quite apart from everything else that's going on. And let me just characterize that if I may, Mike. Vaccines are failing. Vaccines are failing across the board. They were always going to fail but it is now tangible that they are failing. So what we see is: polio, for example—hailed as a success, the eradication of polio—no. Polio is now back and the vast majority of cases we're seeing in the developed world are a direct consequence of the vaccine itself, the oral polio vaccine. You will never eradicate a disease that is caused by the agent that you put in place to get rid of that disease. Measles has failed. There are outbreaks of measles in highly-vaccinated populations and we're seeing the emergence of resistant strains of measles that are no longer immune to any of the immunity produced by the vaccines. Mumps: complete and utter failure for which Merck had to commit fraud to preserve their license and are now in federal court in Pennsylvania. We saw experts in pertussis vaccine coming out recently saying that pertussis is back because we didn't understand how the human immune system interacts with pertussis; we made assumptions upon assumptions, and we may have made some serious mistakes. So across the board, vaccines are failing, and because these are the lifeline for the pharmaceutical companies—their future is invested in vaccines—I think that we're seeing in COVID-19, in the coronavirus, a "hail Mary" pass. They have got to get control of the population once again. They have got to corral us in, and bend us to their will, or they will lose it all...I think there is an element of this on behalf of the public health authorities and the pharmaceutical companies which is essentially a "hail Mary" pass, and it will fail.

MIKE ADAMS: ...isn't this a recipe for the vaccine industry itself to be entirely discredited because so many people might die or be seriously injured?

DR. WAKEFIELD: Yes, it is. And it's interesting that even those involved in the industry, commentators like Peter Hotez and Paul Offit have come out and said, "Whoa, guys. There's so much at stake here. If we get this wrong, we get it wrong [permanent discrediting of the vaccine industry]."

MIKE ADAMS: ...there is one doctor who said that people who don't wear masks are "enemy combatants" now, using wartime language that's very disturbing. They have gained so much power from this. Isn't it now—haven't the people that built this, haven't they been rewarded to such an extent that they have to be thinking, "Let's do it again." ?

DR. WAKEFIELD: That's exactly right, Mike. And over the years when I was in mainstream medicine I dealt with a lot of people from the industry, and it comes back to a point you just raised: are they not in danger of putting themselves out of business? What you will understand, I'm quite sure, is the industry executives don't care. They're not concerned with the longevity of Pfizer or Merck; what they're concerned about is their bonus. And I'll give you an example. The physician, the scientist, who was in charge of vaccines at Merck who was responsible for the fraud with the mumps vaccine—he's no longer at Merck. He's not liable. He's moved on to another highly-paid job; in fact I think he's at Pfizer or Eli Lilly.

But the point of that is that they are only concerned with the short term. And what they know is that they have a massive market for an untested product for which they have no liability. And therefore, all they can do is make a profit. They will make their returns and they can get out. And they don't care Pfizer survived this or not; they don't care whether they are found to have committed fraud and therefore are somehow liable for damages. So it's a very worrying situation.

MIKE ADAMS: ...is the human response to coronavirus more dangerous than the virus itself?

DR. WAKEFIELD: Absolutely. Is the damage being done and going to be done to mankind much greater than the virus itself? Yes. If we look at the Swedish experience and look at the countries that did not lock down: Sweden was a fascinating example of—you look at the mortality curves from this virus, called the Gompertz curves, and mortality is clearly the most important thing; it's dichotomous—you live or you die. It's not like it's a variable that quantifies, “Oh, it was a mild infection, moderate infection, severe,” which is all terribly woolly. Death is a very firm endpoint...you look at the Gompertz curves for Sweden and every other country: they're exactly the same. Lockdown, masks made no difference to this at all, except...[Dr. Wakefield then goes on to explain his idea about the masks and lockdowns being a selection pressure which might mutate the virus]...

~25:00:

DR. WAKEFIELD: Now my big issue: I'm a single-issue voter and health freedom is that issue. It was a clear dichotomy between the Democrats and the Republicans. The Democrats—Joe Biden said: “When I get into the White House, there will be a complete lockdown of this country until we have all taken our mandatory vaccination against COVID.” And President Trump said: “This vaccine won't be for everybody; it will be for those who want it. I'm not going to make it mandatory.” And I'm very glad to say that here in Florida and in Texas the governor has come out and said that this vaccine will not be mandatory. You raised the point earlier, Mike, that the people in line for this vaccine first off will be those health care workers: doctors, nurses in what will have been called “the front line.” They won't touch it—I can promise you, Mike, based on the experience of the Swine Flu vaccine in 2009—they will be the first to say, actually, “Uh, no. I'll wait until many, many more people have had it and we've determined the safety because I know from my professional training that this has not been through adequate safety studies, the risks are completely unknown, and I refuse to be an experimental animal, in effect, for this vaccine.” And so they will face a big, big problem with compliance from amongst the health care workers and then the people are going to say, “Well, hang on. If it's not good enough for them, it's most certainly not good enough for me.” So they have created for themselves an enormous problem and so much hangs on this—the future of vaccination, the future of trust from the public in the public health authorities hangs on this. So much depends on this; it's almost become too big to fail but fail it will.

MIKE ADAMS: And now even when governments are not necessarily going to make it mandatory, as you mentioned the governors of Texas and Florida and many other states and the President himself says it should be a choice, not mandated—and I also have that confirmed from one of his family members that has told me the same thing, that President Trump is

not going to mandate vaccines at that level. But we have corporations mandating them. In the same way that we have corporations such as big tech companies that have decided that they alone control your right to speak, or to share information, your right to participate based on your point of view. We have airlines like Qantas, of course, announcing that international flights would require mandatory vaccines and there's been talk that this kind of policy would be adopted by other airlines, so if you wish to fly you have to prove that you've been vaccinated. Well, we've seen other documents and plans where they plan to roll out vaccine enforcement checkpoints at grocery stores and churches and day care centers and no doubt many other elements of society so that they would make it—even without a mandate, is my point—they would make it impossible to buy food, to worship at your church, to go to a sporting event, to visit your parent in a nursing home, unless you have consented to the vaccine. So it's kind of a work-around mandate—it's very evil—but that's what's happening now. How do we stop that?

DR. WAKEFIELD: I think there are two things, Mike. One is that those front-line workers and the elderly and the obese and people with comorbidities are lined up to get this vaccine soon—it's in them that we are going to see the severe adverse reactions, and that will be the demise of the vaccine. It's a tragic way to have to learn a very, very bad lesson but that's the way it's going to be. The second is that some years ago, Mike, I was on your show. There was a big discussion about arms, guns, the Second Amendment, removing arms from people. And you asked me a question about them and I said, “Well, Mike, I'm from Europe. We don't have guns. It's not part of my body and we don't grow up with it, so I'm not the best person to ask.” I now understand why America has a Second Amendment: to protect itself from exactly this kind of tyranny. That is why there is a Second Amendment. And so much of this was anticipated, so much of where we are right now was anticipated by those who wrote the Constitution, by those who wrote the Amendments, by the Founding Fathers of this country. It's extraordinary how prescient they were, and I came to this country effectively in professional and political exile to continue the work in health freedom and to investigate the safety of vaccines and the vaccine links with various diseases. And I refuse to concede. I refuse to have all of the reasons that I came to this country—the great things about this country—to be threatened, to be compromised, to be removed by pharmaceutical industry profiteering and by the agenda of globalists who see the natural history of America coming to an end.

MIKE ADAMS: Well, since you brought it up, I've openly talked about mandatory vaccines as a form of violent assault. It's medical violence against you. Violence doesn't have to be with a baseball bat; violence can even be at the cellular level or at the genetic level—those are forms of violence. And almost as an experiment, by the way, I have publicly and repeatedly stated openly that if some officials show up at my doorstep—they would have to trespass very far into my ranch to do that, by the way—and if they demand that I submit to contact tracing or submit to a vaccine, I will shoot them. And I've said this publicly over and over again, and guess what? No one has tried to arrest me for saying such things. No one has bothered, because...maybe because this is Texas, and they know I'm not alone. It's not that we're advocating to go out and look for opportunities to commit violence—we want to stop the violence. But we also want to stop it at our doorstep. And assault with a vaccine is a felony assault at least in the state of Texas and in Florida, also. Every individual has the right of self-defense, even through the use of kinetic instruments, firearms, in order to stop

a felony crime from being committed against you. Regardless of whether there's an emergency I have the right to defend my body against your needle, and I assert that right. And I assert it probably with an AR-15, by the way. That's true.

DR. WAKEFIELD: Yes, I think that none of this is to say that if people want to have the vaccine—if they've distilled all the information and they're prepared to go along with it, that's their choice. If you are happy with it—fine, go with it.

DR. WAKEFIELD: Given the way we think all of this might play out, where will the military stand on this? My instinct tells me that the military—certainly the vast majority of the military are patriots, that they would tend to stand with Trump. Where does that play out? Because as you point out in England, they're recruiting the military, certainly the military intelligence, to play a role in surveilling people like you and I. But how will that go down in America?

MIKE ADAMS: Well, this is where politics intertwines with health freedom, and they are inescapably intertwined here. But in my assessment, there's been a great awakening among military personnel, many of whom I count as my friends and colleagues and former trainers and so on—and so I am in touch with people in that realm a lot. They are loyal to Trump even if Trump is not in the White House in this second term and they are loyal to the Constitution except for the higher-level generals that are still left over from when Obama put them into place. But the everyday people—the mid-level people and the front-line soldiers—they are not going to agree to be used as weapons of the vaccine industry. They will disobey orders, I believe, if they are ordered to go start arresting doctors and journalists and people just because of what they've said about vaccines...

...And so this is why, by the way, I think it's important for you and I to be as public as possible so that people know us and know our beliefs and our philosophy, what we really stand for—and you'd be amazed: when I meet groups of military people you'd be amazed how many people say, “Oh, you're Mike Adams! I listen to you! We listen to you on deployment. We download your podcast.” It's incredibly widespread. And even in Texas, emergency response personnel are circulating a lot of my podcasts recently, and I'm sure the same is true for you. People follow you that you never would have imagined. Trust me, it's happening.

DR. WAKEFIELD: I'm very glad to hear that. I think that I'd love this film to get out far and wide, because when we finished doing the production on the film, Mike, we finished filming our actors, we had never heard of COVID-19. And then suddenly it blew up, and it was so relevant because it allowed you to look into the past: the history of vaccination policy from government, from companies, from public, and to see how badly wrong they've got it in every single case. Every single case. And that allows you to look forward into the 'crystal ball' of where we're going with this coronavirus and say, “Actually, this isn't for me.” Based upon past experience, based upon the corruption and the incompetence, I'm not going to buy into this narrative and I'm not going to go along with it.

~51:50:

MIKE ADAMS: ...for these vaccine makers to say, “We know how this is going to act; we're going to take these mRNA strands with endcaps and we're going to shove them into the body and then they're going to magically go into the cells and go right to the ribosomes—and nowhere else—and so on...” No! You're going to be humbled by what happens. It's totally out of your control.

DR. WAKEFIELD: It is. And you're putting it beyond your control as well, and that's the important point you make, Mike: it's that once you've injected this, there's no un-injecting it. Once you've put this autonomously-replicating messenger RNA into a cell that's going to allow it to produce protein within human cells. Then you have the situation where you can't switch that off necessarily—there's nothing you can do to switch that off.

MIKE ADAMS: Right.

DR. WAKEFIELD: If that protein turns out to be analogous to some human protein that induces an autoimmune response, that's it—nothing you can do about that. So it is utterly terrifying and it's this assumption upon assumption upon assumption...again, to give an example, back with measles virus: what they did is they assumed that they could change the route (injection rather than inspiration), the age (the mean age of exposure), the strain, the dose, and that they could combine it with any number of vaccines given at the same time. They assumed that was going to be safe. There is absolutely no basis whatsoever for that assumption; it was completely unjustified. But now, many many years down the line, it's too late. It's too late.

MIKE ADAMS: Well, this is the bottom line of where we are now. The human race is being treated as a grand medical experiment. We are all guinea pigs—and I would say, actually, with the lockdowns we are all POWs in a giant prison camp known as your city or the entire country, the United States—wherever the lockdowns are—and then they're going to say, “You can't have mobility in society unless you agree to this other medical experiment. And that's not going to be the last one of those either. It's going to be six months later: COVID-21—need another vaccine for that, and it's this business model and this model of tyranny and control and obedience that...never ends! Why would they ever end it?”

AW: They wouldn't. And you're quite right on the passport that we're all going to have to travel internationally—which you and I will not be doing. We simply...it won't be just the COVID vaccines. It will be measles, mumps, rubella, chickenpox—all of the vaccines that you might have had as a child—or didn't have as a child—and now they're going to catch you up. It will be all of them...

Note: for observant Jews, Orthodox Jews, modesty issues may exist with Dr. Wakefield's latest film (though I haven't seen it so I can't be sure). My general impression in this case is that it's likely good enough just to look away if that happens. Otherwise I'm sure the content is excellent, since that's just how Dr. Wakefield's work is.

It is very clear that Mike Adams is exactly the kind of person they would like to label a “domestic terrorist.” In fact, anyone at all who believes in medical freedom falls into that category. This

shouldn't dissuade people from questioning and rejecting the official narratives about vaccinations, the “virus,” etc. etc. Benjamin Franklin explained it well when he wrote this:

Those who would give up essential Liberty, to purchase a little temporary Safety, deserve neither Liberty nor Safety.

It might be easy for some to think, “I'll just keep my head down. I'll just be quiet because if I don't then I might get in trouble.” The truth is that most Americans—the majority—are presumed to be already on a watch-list, because the tyrants just want everyone labeled a “domestic terrorist” so they can find some work-around for the Constitution. So each of us might as well do his or her part to wake up others as to just what our country is facing and why. Revolutions have only ever gone in circles, to my knowledge—that's why they're called “revolutions”! Thankfully there is a truly permanent solution which is better than revolution and is explained in my book—that solution is only G-d's design, not one that I could ever take any credit for! (This solution is not yet being implemented in the health freedom movement as far as I know.)

The interview (recommended) continues from there and they cover several other topics. It's just a very relevant interview at this time. I notice that they don't believe the content of *The Contagion Myth* by the WAPF President and Vice President, though they clearly haven't read it yet and perhaps haven't heard of it (though it's clear someone tried to approach them about the topic). Regardless of the cause of the illness (contagious or electromagnetic) it is clear that there are some who wish to use the illness as as a work-around and an excuse to eliminate the US Constitution and to enslave America. Medical personnel and emergency response personnel and military personnel need to know what is going on; they need to know that there are probably at least 100 million Americans who, like Mike Adams, would shoot “officials” instead of getting vaccinated. They need to know this because it's good to prevent a shooting match between American citizens and “their neighbors' sons in uniform,” as G. Edward Griffin correctly says, because that would be an ugly, ugly prospect.

They also need to know there is a treasonous group that is working around the clock to “securitize” “global health” and use it as an excuse to eliminate all rights from Americans (and the rest of the world). They need to know that if they think this is all a bad thing they are the silent majority; they need to know that they are not alone when they refuse illegal orders if the orders may come (i.e. if good people in leadership/command positions are replaced with bad people). Like Mike Adams and Dr. Wakefield, all the rest of us in the health freedom movement are working to prevent the violence that will happen if there is an attempt at a forced vaccine. I am not so worried, today, that they would try to use the military to distribute forced vaccinations in America; I believe that was the thought-form they used to shift the Overton window to the left enough that the more immediate problem becomes plausible: I'm more concerned that they would try to ban unvaccinated people from grocery stores and other places and try to use the police to enforce those sorts of fake laws. Police must refuse those fake laws if it comes to that. The Thick Red Line is an organization that works to keep police from enforcing victimless crimes and encourages police and citizens to unite with each other (and hopefully with the Constitution), not politicians. [80]

Below I have pasted an excerpt from the 'CONCLUSION' chapter of my book and have modified it:

They don't just tell Americans:

Simon says: "Go to war."

Simon says: "Pass the Patriot Act."

Simon says: "Get irradiated and go through naked body scanners at the TSA."

Simon says: "You don't have freedom of speech."

Simon says: "Don't be religious anymore."

Simon says: "Hand over your guns."

Simon says: "Roll up your sleeve—it's for your own good."

Simon says: "Take this pill three times per day."

Simon says: "Don't see your grandmother again."

They don't do any of that! They have to have something believable. They have to have plausible deniability. They need a pretext. Then, when they have a pretext, they try to say, "We need to take away your rights in order to protect your rights," and they hope it makes sense (which it doesn't, because it is a lie). Maybe for the Jews they'd try to make it sound Jewish, i.e. "Shimon says..."

In short, the target audience of this Safety Alert booklet needs to act in such a way that they know that they'll all be on the right side when the history books are written.

But why did all of this happen to us? The answer is simple and is explained at length in my book. It's because our country turned its back on G-d. Does a brazen, sinful nation truly deserve to have freedom, in G-d's eyes? Surely not. So a dictatorship was set over us to make us cry out to Him for help and realize that we cannot have good lives without following His Perfect Instruction Manual for Life. A surveillance state arose to remind us that "There is an eye that sees and an ear that hears and all your deeds are written in a book," that G-d is always watching and listening and recording regardless of the level of freedom from tyrannical government that we may enjoy.

In my view, the words that come out of our mouths can be far more dangerous than the coronavirus. I don't think the coronavirus is contagious; I lean strongly towards the case made by Dr. Tom Cowan and Sally Fallon Morell (as advanced in their new book *The Contagion Myth*). But the concept of contagion—more accurately, in the case of this "virus," the concept that breath can kill—is a useful one, though not in the way we've been told: it's useful because it shows us that "life and death" really are "in the power of the tongue" and that breath can kill. An entire neighborhood could be destroyed through back-biting, peddling, gossip, tale-bearing... "Did you hear what So-and-so said about you?" It's enough to make the blood drain out of someone's face. The gossiper kills three, folks: the listener, himself, and the subject of the gossip—yes, even if the gossip is true! The masks, dangerous though they are (I don't recommend them at all), have been reminding us of the *metzora* (sometimes mistranslated as "leper"), the individual who was isolated from the Jewish nation because of being afflicted by the hand of Heaven for his great sin of gossip. He had to cover his mouth and say, "Contaminated, contaminated!" while walking around so that people would pray for him. Once he was healed he could resume normal life with care to avoid the terrible sin of gossip. Aaron and Moses had a righteous sister, Miriam the prophetess, who became one of the most conspicuous of the *metzoraim* (the plural form of that word) featured in the Orthodox Jewish

Bible (the *Tanach*) when she inadvertently spoke against her brother Moses.

Incidentally, I have noticed that the Orthodox Jews (Guess what? They've had the right religion all along! Won't the nations be surprised!) are certainly well aware of the connection between the coronavirus masks and the *metzarah*:

“The COVID-19 masks reminded us that we need to shut our lips to block harmful statements and gossip. [81]”

The importance of this cannot be overstated. Please read my book for more information.

As a Noahide (a righteous Gentile who receives instruction from the Orthodox rabbis) I also should point out there really are other reasons we shouldn't ignore details of the government response to the “virus”; we've been scolded consistently by the media for going to the beach, etc. There is no scientific basis for scolding people about going to the beach; even if the illness is contagious that would not be a way to give others the illness. There is, however, a moral basis for all of the scolding and chastising people for going to the beach (at least in the ways beach-going is typically done today in this country), since there are very extreme modesty concerns! So we should listen to the words of the oppressors, because even when they're saying those words about the wrong things there might be a good and useful and actionable take-home message buried in there somewhere. America should be scolded for the immodest beach-going (i.e. running around almost naked) but not because of some contagion.

The sins of the nation are the determinant of the kind of government under which it will be ruled. A righteous people can have a righteous government, but it's increasingly clear that a wicked people cannot. Further, we see that even a pro-medical freedom leader such as President Trump has been influenced by the wrong people; this isn't even his fault, but ours. When the righteous King David—the most righteous of all the kings of Israel (he was the measuring stick against which the other righteous kings of Israel were measured!)—was incited by G-d to take a census of the Jewish people, something he would ordinarily never do, this was on account of the sins of the nation and not his fault. He was devastated when he learned what he had done. Regardless of whether President Trump gets a second term, I believe that whenever he leaves office his heart will smite him and he will say, “What have I done? I participated in Operation Warp Speed and told the people I believed it was a great idea; I forgot entirely that I had planned to set RFK, Jr. as head of a vaccine safety commission, which would have entirely wiped out the industry and kept the children from being maimed and longer; I have destroyed this country.” But it's not his fault! I believe that his free will was interfered with by the Creator, as it says in Proverbs 21:

“<sup>21</sup>Like streams of water is the heart of a king in the hand of HASHEM, wherever He wishes, so He directs it.\*”

And the footnote (\*) in the ArtScroll Tanach Stone Edition gives:

**21:1.** Because a king's choices affect so many people, God may intervene to direct them, as a farmer might direct the flow of a stream to irrigate his fields. (Page 1598)

I believe that the whole reason why we are oppressed is because the oppressors themselves are like

a sword in the hand of G-d, an instrument used to refine us. When they have outlived their usefulness in this capacity—“when they harm instead of help”—G-d will deliver us from them.

If this warning is not heeded, then I believe that it won't matter if the right people get into office—the sins of the nation really are the force governing America today.

But if the warning is heeded, then “conspiracies,” which have been “the engine of history” in the words of the great political theoretician and tireless activist G. Edward Griffin, will cease to be the engine of history. Instead, repentance will be the engine of history and good people can really start enjoying life rather than fighting tyrants.

*This discussion is limited to a quick overview of the physical reality of the neurological injury I sustained in late 2009 as a result of taking the Swine Flu vaccine for that fake pandemic.*

**A**S IT TURNS OUT, the many variations of that shot—the 2009 Swine Flu vaccine—were very injurious here in the United States (miscarriages) but also in Australia (seizures) and Scandinavia (narcolepsy). [82] I think you health care professionals and first responders and military personnel should say: “You want me to take a Swine Flu vaccine? When pigs fly.”

Before I got the shot I did some hiking and backpacking in my spare time. I'd go, alone or with my friends, out to do strenuous hikes or backpacking trips. Carrying a heavy load up a mountain was often part of my idea of fun. I would also go out and do some pretty significant bicycling sometimes. There was a desert day trip that took me up to a mountain pass and back down, and there was even a trip from my home in Boring, OR down the Springwater Trail all the way to the Sellwood Bridge and back, a trip of about 50 miles. There were some very minor mountain biking adventures. Though I may have been tired at the end of a long day, I was basically in decent health. I was missing a lot of information at the time, sure. I may not have been truly an athlete but I was physically okay. I had a very heavy course load in college and did a lot of trumpet playing there—enough of it that a lot of folks assumed I was a music major. Trumpet playing can be loud.

In very late November or early December 2009, a friend of mine pressured me to get the Swine Flu vaccine. I believed I had already been exposed that flu and didn't think it was a real problem, but in an effort to make my friend feel better I went to a grocery store pharmacy and took the vaccine. To make a long story short, I started getting migraine headaches within a week or two, and they kept getting worse and more frequent. In a short time I was having a migraine headache 24/7. I ultimately had to withdraw from my fourth year of biochemistry and biophysics at Oregon State University, because by that time I was not doing well in the few classes I had left. The Disability Access Center helped me get some lenience from my professors, which was kind but not enough to keep me afloat. The pain and helplessness ultimately caused me to search for answers, and the rest is history.

Ultimately I have recognized that this very serious chronic illness has been one of G-d's perfect designs, and it was designed to wake me up out of the 'trance' in which I was living in college. Had I not had something extreme happen to break me out of my foolishness, I would have gone full speed ahead and never looked back well enough to see what was going on in the world (and more importantly: I wouldn't have looked back well enough to ultimately find the one true religion, which is what matters the most).

Folks, you need to know something: there is a G-d and He has a set of instructions for us to keep—and we are capable of keeping it, just as He designed us to be capable. If you don't do what's right in G-d's eyes, He might do something to wake you up out of your daydreaming and it might not be very easy to live with. That's what happened to me. And I want you to know that there is nobody else in the world I would rather be than myself—that just comes with the territory when you serve the one true G-d of Israel because you are, by definition, being your best self. But I'd rather people learn the painful lessons through my example rather than going through all the pain themselves! I know that G-d only does good—even when it's not openly-revealed good. You people do have the

freedom to go ahead and take the coronavirus vaccine(s) and get autoimmune disorders, neurological diseases and potentially infertility—or even ultimately get killed by the vaccines, i.e. through “pathogenic priming”/“paradoxical immune enhancement”/“vaccine enhanced disease”. *I'll start with a dream that I had years ago and move on to some recent news items.*


The dream: About 6 or 7 years ago, at a time when I was becoming acutely aware of the dangers of vaccinations, I had a dream that some people were going to a vaccine church and were going to be forcibly vaccinated there. Now during the “coronavirus” lockdowns, it shouldn't be any great surprise that this dream has come back to my recollection a lot. I'll say I think it's possible that G-d gave me this dream, because not only does it speak to the fact that there are churches which are now actively teaching their members to agree to mandatory vaccinations but it also may speak to the fact that our society in general is being told to worship the germ theory. This year we were told to make a “sacrifice,” to sacrifice Thanksgiving to the false gods of the germ theory. We were told that strip clubs should remain open because it's protected free speech under the First Amendment, but that houses of worship should be closed. Obviously, I'm not recommending people should believe in qristianity, since I'm a Noahide and, thankfully, have done my homework in order to arrive at that conclusion. The germ theory is being used as an idol; an idol is a replacement for G-d. Also think of it this way, folks: we were told that garden centers were too dangerous but grocery stores are essential. There were Victory Gardens in World War II. When the government makes any restrictions standing in the way of gardening you should realize that the war—and the target population—has clearly shifted to American soil. They want victory over Americans.

The Weston A. Price Foundation published a very interesting illustration in the new Fall 2020 issue of their journal *Wise Traditions*; it shows a lady bowing down to a Louis Pasteur shrine (Pasteur was the most prominent proponent of the germ theory). I've pasted it below and blurred out the immodest part with image manipulation software (please see next page).

In other news: The US Supreme Court gave a favorable ruling to the Orthodox Jews in NY. [83] After months of hearing about 2<sup>nd</sup> Amendment sanctuary counties (before the lockdowns ever started) in Virginia and many, many other states, there is now a county in Virginia which is refusing to enforce coronavirus orders (a 1<sup>st</sup> Amendment sanctuary county); Rhode Island has a city that is doing the same thing. [84] Unsurprisingly (since this is what the media has been leading up to for all these months), a California mayor has stated that not wearing a mask is an act of domestic terrorism and people should be arrested for it. [85] In contrast with the “surveys” parroted on the mainstream, government-approved media stations—which I believe are fraudulent—a recent survey shows that about 90% of those responding to it are against the coronavirus vaccine. [86] Cornell University made a strange move, saying that some of the vaccine exemptions it would offer to students would be on the basis of their race; Cornell said that “BIPOC” students (that apparently is a ultra-politically-correct term for Black/Indigenous/People of Color) could be exempted from the flu shots since black people were used for so much medical experimentation, historically speaking (perhaps they're referring to the Tuskegee experiments, for example, but I'm sure Vera Sharav of AHRP could tell us about a lot worse stuff that isn't famous). [87] It's easy to stand back from this and laugh, “Now they've gone too far. Nobody reading about this will ever be a liberal again!”

According to Children's Health Defense, there is evidence of pathogenic priming—a possible safety signal—in older adults who had the Pfizer coronavirus vaccine. [88] Do you doctors and nurses know what a safety signal is? That's a signal in the data which indicates there may be a safety problem; safety signals are common in the VAERS system (but you should know this very well already because of thoroughly studying reference 1. [1] The California Restaurant Association won a case against LA County for their dining restrictions. [89] The UK warns: don't give the Pfizer

vaccine to people with susceptibility to allergic reactions. [90] RFK, Jr.'s platform Children's Health Defense has recently published an article [90a] chronicling their many bold, on-going attempts at warning “regulators” (so-called) about the dangers of polyethylene glycol (PEG) in both the new Moderna and Pfizer coronavirus vaccines; this article makes it clear that there isn't any great doubt as to why allergic reactions would be happening in the recipients, since PEG is quite well-known for this. The author stated: “Unfortunately, the public is now left to bear the burden of exposing these lapses in safety.” That means you!



A NY lawmaker has proposed a law to force citizens to get a coronavirus vaccine. [91] Bell's palsy is one of the “non-serious” adverse events which has, so far, been reported in those who received the Pfizer vaccine; the FDA claimed it was not statistically significant (I question this). No Bell's palsy was reported in the supposed control group. I personally think Bell's palsy is pretty serious. [92]

Again I implore readers to take a very careful look at reference 1 [1]—and most especially its four primary sources—which provide strong evidence that safety signals are now tampered with in the US VAERS, a system set up (ostensibly) to look for problems with vaccine safety.

On December 10<sup>th</sup> 2020, FOX News ran a segment about a nurse who volunteered for one of the coronavirus vaccine trials and documented her reaction; [93] it was stated that she got a fever of 104.9 degrees F after the second shot, though it wasn't revealed as to whether she had received the placebo or the real vaccination. Shockingly, she told the host that her response was to take Tylenol. Apparently she hasn't read Mary Tocco's article about acetaminophen (Tylenol); Mrs. Tocco draws on the work of William Shaw PhD who believes that acetaminophen: shuts down “four metabolic pathways” in the brain, “impairing detoxification”; “shuts down glutathione production” (glutathione is low in people with autism); “blocks the production of antibodies” (I thought antibodies were the goal of vaccination); “causes immune suppression”; is “the #1 reason for liver failure in the US”; is “responsible for 56,000 emergency room visits each year”; is mixed into many over-the-counter and prescription drugs; and kills fetal liver cells and leads to childhood asthma when given in pregnancy, just to name some of the risks. Dr. Shaw reportedly also says that the rates of autism are much lower in Cuba and believes this is because they do not allow the use of Tylenol there. [94] In my opinion, then, the FOX News segment not only normalized a serious adverse event but gave out a “one-two punch” prescription for brain damage to its viewers: coronavirus vaccination plus Tylenol. That same FOX News page also included a statement that over 3,000 people are dying in the US every day from coronavirus and that the problem is worse than 9/11; it is abundantly clear that the major news outlets are expected, within a few short months, to say that people who won't take a coronavirus vaccine are “domestic terrorists.” In my view, the majority of America, then, would be expected to fall into that category (which very clearly goes to show that the officials are merely tyrants). Even before the lockdowns started or the “new” coronavirus was known, a “Never Trump” type of Republican political and media consultant wrote publicly:

Anti-vaxxers are a scourge and a strong argument for re-education camps, the immediate seizure of their property, and putting their children into protective custody. [94a]

In my book it was shown, with G-d's help, that 'The Iron Mountain Motive' has governed American politics and medical politics. The use of The Iron Mountain Motive has involved the permanent continuation of war and/or “replacement institutions for the nonmilitary functions of war.” It is so very, very clear that the government response to the “coronavirus” is serving as one of those replacement institutions for the nonmilitary functions of war. There is a pervasive use of wartime language in the current outbreak of breathing illness: the “front line” now refers not to soldiers but to medical personnel! Countless other examples of wartime language abound in this outbreak. But one of the ultimate goals of the government response to the outbreak is (and always has been) to label vaccine refusers as domestic terrorists, plain and simple. If there is a war and there is a front line, there must be an enemy. The “enemy” (according to the technocrats) is not “the virus,” folks—it's people like you and I; it's every normal American. So the expectation is: as more people refuse, higher and higher percentages of the country may be characterized by the media and/or the government as the fabled “Y'all Qaeda,” i.e. every normal American is a terrorist, especially if he

has a pickup truck and likes barbecues and that sort of thing. They already say this about people who don't wear masks, as we have seen. They have been saying for months that the amount of death is as bad as/worse than “a 9/11 every day.” They aren't using that language by mistake; they're gear-ing up to say that the enemy is “Y'all Qaeda,” and that means everyone.

“Two steps forward, one step back”? Some<sup>1</sup> have pointed out that the strategy of incrementalism, in the field of social engineering, often employs “The Totalitarian Tiptoe,” also known as “Two steps forward, one step back,” i.e. :

*Two steps forward, one step back. Two steps forward, one step back.*

*Two steps forward, one step back. Two steps forward...guess what? You're in the camps.*

How is it meant to work? By traumatizing the population with a draconian proposal two steps removed from the status quo and then opting for something slightly less extreme—a draconian proposal one step removed from the status quo—social engineers are confident they can achieve their goals in our society gradually and with consent; they are confident that the emotion of relative relief that happens once the more extreme proposal is withdrawn will outweigh ideological objections of the governed, meaning they believe we don't think (except with our emotions). The social engineers I am referring to are the ones who have been writing the scripts for the national and local news stations, etc. In “The Totalitarian Tiptoe,” the goal of the social engineers all along was to change society by one draconian step, but they believe that the most efficient way to shift the Overton window is to first pretend they want to change society by two steps—this amounts to lying right from the beginning.

I learned from *The Contagion Myth* that Ventura County, CA health officials were understood to have said that people would be forcibly removed from their homes and put into quarantine; the officials have apparently tried to “clarify” what was meant by saying it would be voluntary, and this could amount to backpedaling. [95] However, with the known, previously-mentioned 'kidnap quarantine' recommendations (as I call them) given by WHO, [72] there can be zero doubt this is the ultimate goal of those who have been leading the charge—just a goal for a somewhat later time. From *The Contagion Myth* I also learned that separating mothers from newborns was recommended by the CDC and ACOG if a mother would test positive for coronavirus. [96] A later article from July says that AAP no longer recommends this approach; [97] nevertheless even *The Guardian* in the UK, a mainstream news website, is protesting (as of November 2020!) that the ruinous and unnecessary policy has continued [98] and an October article in *Business Insider* even tried to popularize a study that found babies shouldn't be separated from their mothers. [99]

A disturbing article on the *National Geographic* website (*National Geographic* is not a magazine I recommend since it very often contains nudity!) explores a range of possibilities related to how a coronavirus vaccine might be mandated. The article starts off with the statement of a bioethicist: “We’re not going to get to the point where the vaccine police break down your door to vaccinate you...” [100] Whether intentionally or not, this article was written in a manner consistent with the trauma-based social engineering tactics that are exemplified here in this subsection, i.e. first, terrify the readers by offering the notion that the government has been considering having police break down doors for that, and then 'comfort' them with seemingly-less-vicious public health policy ideas to engineer consent. RFK, Jr.'s platform Children's Health Defense recently released a new article

claiming that a piece of a Bill Gates interview from June 2020 TED Talk had been edited out; reportedly the part about him saying we would all need digital vaccine passports is what has been removed. [101] I haven't seen or found the full original video to review it against the full allegedly-edited one (and trust that Children's Health Defense will supply it for verification) but have been very impressed so far with the quality of evidence they present, especially the scientific references they supply. It may be hard to provably assign malice (the malice which is evident in deceptive social engineering tactics) to single individuals who have been involved in the government response to the outbreak of respiratory illness, but it is not at all hard to notice the general trend, even from the small number of examples in this subsection—"The Totalitarian Tiptoe."

More about solutions: I'm not going to tell you  $2 + 2 = 4.5$  in order to slowly wean you off of the false belief that  $2 + 2 = 5$ ; you can handle the truth. *The Contagion Myth* by WAPF was published recently and immediately banned on the website Amazon.com; then it jumped all the way to the #1 spot on the Top 100 Bestseller list at Barnes & Noble. [102] It was written by nutritional giants and I believe it may be one of the greatest scientific discoveries of the century—I still have references to check, though. It contends that 5G is the cause of the respiratory outbreak and that it is not contagious. I'll leave the details up to the reader to find in their truly fascinating book. But what, then, is the cause of 5G? About ten years ago, people began anti-SmartMeter activism, knowing the dangers of the microwave radiation. Yet most of them didn't give up the wireless internet or cellular telephones. In my view, this is a serious sin because they knew better than to absolutely destroy the DNA in the vicinity of the device(s). Thankfully, I gave these up about five years ago and life is so much better for it (and I'm more productive and certainly don't miss those things). Cable internet and corded landlines are good. The Big Boycott is the only answer to stopping 5G, much more so because of the sin factor than the financial factor. Stop buying products and services from the wire-less sector and they just cannot afford to put up new towers or run the existing ones. But more than that: we'll be deserving of getting our freedom back. The FCC blocked local governments all over this country from stopping 5G, but I believe the Heavenly Court will look on us favorably if we turn back from the sin of destroying our own DNA, the DNA of our families, and the DNA of our neighbors. (According to a 2013 paper by a former microwave weapons expert for the British Royal Navy, about 60% of women are expected to have birth defects in their children from exposure to wireless internet alone within about 3 generations, and an American scientist in academia at a university has shown that the famous NTP study on cell phones revealed much different results than were claimed.) [103,104] So, ultimately, the germ theory of disease transmission may have been terribly misguided but the sin theory of dictatorship is the correct one: G-d surely sets tyrannical, rogue governments over sinful nations to encourage repentance. There is more about this concept in my book.
